

### WHO WE SERVE

### COMPANIONSHIP

### LAUNCHED 2003

Companionship is at the root of all we do. When Jane Hart founded our ministry, she was heeding God's call to train 200 hands in Jacksonville. Companionship services include friendly visits, telephone reassurance, advocacy, yard work, transportation, respite care, light housekeeping, and grocery shopping. Our Card Ministry and Prayer Team also fall under our Companionship Program.

Ms. Thelma has a phone buddy, Tina Hill. Hart Felt Ministries volunteers called seniors living alone during the COVID-19 pandemic to check on them. This is when these two women connected. Tina has continued to call Ms. Thelma weekly to check up on her.

"She's been a constant ever since," Ms. Thelma said of Tina. "She is my spiritual and emotional crutch. I can talk to her about anything, and she's been there. She's the most wonderful human being. She's just great."

> Here's one of our many "God makes the matches story!" When we introduced volunteer Frank Healey to his new client, Mr. Franklin, the client's daughter recognized Frank - a retired physician - as the doctor who operated on her mother. She was immediately touched and started crying, saying, "He added 10 years to my mom's life!" Frank is going to clean out Mr. Franklin's gutters, pressure wash his back porch, and be a companion to him. They also plan on watching football games together. What a story!

A group from Jacksonville University did a yard clean up for Ms. Peggy as part of the school's Charter Day. After the clean up one of the volunteers, Fettie Blackwell, reported that it was a "WONDERFUL EXPERIENCE and an extreme pleasure to serve Ms. Peggy. We accomplished much and are grateful for the opportunity to serve."

Ms. Carol and Mr. Bill met their new volunteers, Laura and Gordon Coppage. Mr. Bill was in the Navy and enjoyed talking to Gordon who is an aircraft mechanic at NAS Jax. At the initial visit, the Coppage's discussed bringing their laptop over so that Ms. Carol and Mr. Bill can video chat with their family who lives in Oklahoma.





### FALL PREVENTION

### LAUNCHED 2005

The Fall Prevention Program includes building wheelchair ramps and installing railings and grab bars.



The Mandarin Rotarians built a ramp for Mr. Fred. After the team left, Mr. Fred's daughter texted Louis Dunbar to say how much her Dad loves the ramp. When our driver, Chuck, picked up Mr. Fred, he reported, "The new ramp facilitated a very easy and safe movement from Mr. Fred's house to the van!"

### THERE'S A STORY EVERY DAY: HART FUND STORIES

Ms. Mary had a stroke and needed an ADA compliant toilet installed. Snyder Plumbing installed the new toilet for her and volunteers Jack Morgan and Marty Williams installed grab bars.

Like so many of our clients, Ms. Mildred is struggling with the increased cost of food and utilities. We helped with her mortgage and she was very appreciative.

Ms. Marva's son had a critical injury forcing her to travel to take care of him. The additional expenses left her unable to pay rent. We paid it and she said, "Thank you so much. This really helps me out!"

Ms. Patricia's son moved out of their apartment but left his 8-year-old son behind, also leaving her with additional expenses. We helped Ms. Patricia with her utility bill.

Ms. Gussie is 94 years old. She had a plumbing/pipe issue that resulted in her toilet backing up into the bathtub. She was having to go to her neighbor's home to use the restroom. Our plumbing contractor was able to find a solution to get her bathroom in proper working order again.

Ms. Jackie is raising her disabled granddaughter and was only recently approved for disability payments (for her granddaughter). She needed help with her rent. After we told her we paid it she said, "Oh My lord! Thank you, Jesus. Thank you so so so much. I'm about to cry. Praise the Lord. Oh my gosh. You have no idea. I was not expecting this. Thank you, God bless you!"

Ms. Lucille is a stage 4 colon cancer survivor. Her husband called us when their water heater went out. Snyder Plumbing was able to replace the water heater and Ms. Lucille said, "You people have always been so good to us and we sure do love you!"

Mr. Bernard is blind and made some errors on his bills which led to getting behind on his rent. We were able to bring him current and he now has a caregiver helping him pay his bills. They both were grateful for the help and said, "Thank you very much for everything you do for the senior citizens!"

### TRANSPORTATION

### LAUNCHED 2019

Access to medical care and groceries continues to be a huge need for the senior population in our area. The Transportation Program meets this need while also delivering a dose of companionship along the way. Our clients love our drivers - Tori Heinzel, Laura Gabel, and Chuck Shelton - and look forward to trips with them.

The Transportation Program launched in 2019 with one van and one driver. Fast forward to 2022 and we now have three vans and three drivers! While the growth of the program in and of itself is exciting because we can meet the transportation needs of more seniors, we are most excited about our geographic expansion. The addition of Van 3 led to our serving clients in the downtown core where needs are greatest and the resources are scarce. We are thrilled to report that we are now transporting 16 clients who live in Health Zone 1. Ms. Emma is one of the clients we can now serve!

Did you know that our drivers don't just drop and go? They sit and wait or accompany the client, helping assist with check-ins at appointments.

### What does Ms. Gracie have to say about the Transportation Program?

"Someone's sitting there waiting for you, and you know they're waiting. You can depend on that person. When you come out the door, you know right where they're sitting," Ms. Gracie said. "It makes me feel wonderful. It makes me feel like a human being, not just a number or a patient."

From the time you meet them, you feel welcome. You feel like they want to help you.




